The philosophy adopted by the Siouxland Soccer Foundation is to create an environment that encourages player skill development within team play, sportsmanship and above all else, FUN!

What We Offer:

Dollar for dollar, the United League offers the best VALUE of any local soccer program. All players are guaranteed 10. The Micro and United League also features these additional benefits:

- **Micro-U6** includes a free t-shirt.
- **Certified referees** who are able to keep better control of games, thereby helping to keep your child in a safe environment.
- Supplemental insurance coverage for each player over and above your own health insurance.

When:

- All Divisions will play games this fall on either Monday, Tuesday or Thursday evenings. Games will be played beginning at 5:30

Equipment:

Shin guards are **mandatory**. Rubber cleats are optional. **No jewelry allowed, including earrings.**

Volunteer Opportunities:

To administer a quality program, volunteer help is vital. The Siouxland Soccer Foundation is run by volunteers, and **everyone is needed!** If your child is enrolled in the United League, you can help to make sure their experience is enjoyable by volunteering to be a coach, assistant coach, team parent representative, or soccer committee member. If you are interested in volunteering your time to help children have a positive experience, please sign up today.

Team Assignments:

Our goal is to form teams by school, locality, and grade whenever possible. Team or coach assignment requests will be considered, however we are unable to guarantee them.

Coaching:

Creating an environment that promotes the philosophy of the United League starts with good coaching and sportsmanship. To ensure this, the United League provides its coaches with educational programs that provide proper instruction through clinics conducted by Siouxland's top soccer educators. Volunteer coaches are strongly encouraged to attend coaching clinics sponsored by the Siouxland Soccer Foundation. The clinics are designed to help coaches teach skill development and proper techniques to reduce risk of injury to the players.

Age Divisions and League Format:

The following age groups are offered, followed by the game format. For example, the under 8 age group will play 5 versus 5.

Age divisions are based on current age as of July 31, 2010.

- **under 6** (4 and 5 years old by 7-31-10) - 3 vs. 3 • 30 minute practice and 30 minute game
- **under 8** (6 and 7 years old by 7-31-10) - 5 vs. 5 • (4) 12 minute quarters
- **under 10** (8 and 9 years old by 7-31-10) - 6 vs. 6 • (2) 25 minute halves
- **under 12** (10 and 11 years old by 7-31-10) - 8 vs. 8 • (2) 30 minute halves
- **under 14** (12 and 13 years old by 7-31-10) - 11 vs. 11* • (2) 30 minute halves
* 11 vs. 11 Numbers Permitting

Registration Information:

Registration will end on August 1st, games are scheduled to begin August 24th (weather permitting). Your registration includes the costs of administration, materials, referees, field usage, supplemental medical insurance, and the use of a team jersey.

Refund Policy:

If a player drops from the league after August 24th, 2010, **no refund will be given.** Prior to the beginning of the season, a refund will be made with a \$10.00 administrative charge.
